Since the 2007 standard, the Home Office Centre for Applied Science and Technology (CAST) has engaged with a range of stakeholders to establish a set of operational requirements for the Home Office Body Armour Standard (2017). These included the National Police Chiefs Council (NPCC), the Police Federation, end-users, manufacturers of body armor, test facilities and technical experts.
